SPRINKLERMAN™© COLORING CONTEST

Fire Prevention Week, October 4-10, 2009, is one of the best times to talk to the children in your life about fire safety and fire sprinklers. It is a great time to explain about fire hazards and difficulties once a fire begins. Share with them ways to prevent and protect against fire, including sprinklers. Pass along the knowledge about sprinklers and the benefits they can provide in homes, work places, and recreational areas.

Sprinklerman™© coloring books were introduced around Fire Prevention Week in 2003. For the fifth time, one of the pictures can be found both in GrassRoots and on the NFSA website (www.nfsa.org). Share the picture with the children in your life and have them color it. Then send it to: Coloring Contest c/o Victoria Valentine, NFSA, 40 Jon Barrett Road, Patterson, NY 12563. Do not forget to include child's name, age, parent/guardian's name, address and phone number on the form at the bottom of the drawing. Entries will be separated into four categories based on age: 3-4, 5-7, 8-9 and 10-12. The prize for each category will be a \$50 US Savings Bond. Entries must be received by October 31, 2009. Winners will be notified by November 30, 2009. Winners will be announced in the December issue of GrassRoots and on the NFSA website.

Rules:

- 1) Contest open to children 12 years of age or younger. Prizes will be awarded to the winners' parent or legal guardian. Void where prohibited.
- 2) Employees and immediate family members of employees of NFSA are not eligible to participate.
- 3) To enter, color in the contest form, fill out the entry form completely and mail entire sheet to: NFSA Sprinklerman Coloring Contest, 40 Jon Barrett Road, Patterson, NY 12563.
- 4) Entries must be postmarked by October 31st, 2009. All entries become the property of NFSA.
- 5) Entries must be filled out completely and legibly to qualify. Sponsors are not responsible for lost, illegible, incomplete, misdirected or late entries. Any mistake in the entry information will void the entry. Only one entry per person will be permitted.
- 6) From all NFSA Sprinklerman COLORING CONTEST entries, one (1) winner will be chosen from each age category: 3-4, 5-7, 8-9, and 10-12. Winners will also be announced in the following issues of GrassRoots and SQ.
- 7) The winners to be selected by 11/30/09. Winners need not be present to win. Winners will be notified on or after 11/30/09 via daytime phone number. Winners will be selected at the discretion of the sponsor. All decisions are final and binding.
- 8) Winners' parent or legal guardian agrees to use of the winners' names/voices/ likenesses in publicity and advertising without further compensation, except where prohibited by law. Winners' parent or legal guardian acknowledges that the sponsors have the right to publicize and broadcast the winners' name, the fact that they won and all matters thereof. Parent or legal guardian must present proper identification to claim any prize. Child's social security number will be required to issue the savings bond.
- 9) Winner will be responsible for any and all local, state and federal taxes incurred by their participation in contest.
- 10) Odds of winning depend on the number of entries received. No substitution or transfer of prizes permitted. Prizes may not be exchanged for cash or any other considerations.
